

In May 2025 the volume of remittances transferred via international money transfer systems (hereinafter - IMTS) was 156.0 thousand transactions in the amount of 68.6 billion tenge. Compared to April 2025, there is an increase in the number of transfers by 3.1% and an increase in the volume of transactions by 14.1%.

Kazakhstan's commercial banks and JSC «Kazpost» provide to the customer's remittances services through IMTS such as the Golden Crown, Western Union, MoneyGram and others IMTS.

IMTS are used by the Kazakhstan's population as for transfers within the country and for sending /receiving money transfers abroad / from abroad.

The share of remittances carried out through IMTS on the territory of Kazakhstan in May 2025 is 4.3% of the total number of transfers and 3.9% of the total volume of remittances. The share of remittances sent abroad is 95.7% and 96.1%, respectively.

## CROSS-BORDER REMITTANCES

### REMMITANCES SENT ABROAD

In May 2025 abroad were transferred via IMTS 149.2 thousand transactions in the amount of 65.9 billion tenge. Compared to April 2025, the number of money transfers sent increased by 3.6%, the volume increased by 14.8%.

In terms of the volume of money sent from Kazakhstan abroad, the leaders are: Uzbekistan – 25.7 billion tenge (share of the total amount – 39.0%), Russia – 17.9 billion tenge (share – 27.2%), Turkey – 10.6 billion tenge (share – 16.1%), Georgia – 3.3 billion tenge (share – 5.0%), as well as Kyrgyzstan -2.0 billion tenge (share – 3.1%).




### *By currencies*

The main share of carried out remittances sent via IMTS was in US dollars (the share of the total number of sent transfers was 18.5%, the share of the total volume of sent transfers was 32.7%) and in Kazakhstan tenge (67.3% and 57.2%, respectively).

### **RECEIVED REMITTANCES (FROM ABROAD)**

In May 2025 from abroad to Kazakhstan were transferred via IMTS 50.9 thousand transactions in the amount of 19.0 billion tenge. Compared to April 2025, the number of money transfers received decreased by 7.8%, and the volume of operations decreased by 1.3%.

In terms of the amount of money received from abroad, the leaders are: Russia -4.6 billion tenge (a share of the total amount - 24.2%), the United Kingdom – 3.6 billion tenge (a share of 18.8%), Uzbekistan – 2.0 billion tenge (a share of -10.4%), the United States of America – 1.83 billion tenge (a share of 9.6%), as well as Turkey – 1.55 billion tenge (share – 8.2%).


