

In June 2025 the volume of remittances transferred via international money transfer systems (hereinafter - IMTS) was 148.3 thousand transactions in the amount of 67.3 billion tenge. Compared to May 2025, there is a decrease in the number of transfers by 4.9% and a decrease in the volume of transactions by 1.8%.

Kazakhstan's commercial banks and JSC «Kazpost» provide to the customer's remittances services through IMTS such as the Golden Crown, Western Union, MoneyGram and others IMTS.

IMTS are used by the Kazakhstan's population as for transfers within the country and for sending /receiving money transfers abroad / from abroad.

The share of remittances carried out through IMTS on the territory of Kazakhstan in June 2025 is 4.5% of the total number of transfers and 3.9% of the total volume of remittances. The share of remittances sent abroad is 95.5% and 96.1%, respectively.

## CROSS-BORDER REMITTANCES

### REMMITANCES SENT ABROAD

In June 2025 abroad were transferred via IMTS 141.6 thousand transactions in the amount of 64.7 billion tenge. Compared to May 2025, the number of money transfers sent decreased by 5.1%, the volume decreased by 1.9%.

In terms of the volume of money sent from Kazakhstan abroad, the leaders are: Uzbekistan – 26.9 billion tenge (share of the total amount – 41.6%), Russia – 17.5 billion tenge (share – 27.0%), Turkey – 8.5 billion tenge (share – 13.1%), Georgia – 3.5 billion tenge (share – 5.4%), as well as Kyrgyzstan -2.0 billion tenge (share – 3.2%).




### *By currencies*

The main share of carried out remittances sent via IMTS was in Kazakhstan tenge (the share of the total number of sent transfers was 69.6%, the share of the total volume of sent transfers was 61.1%) and in US dollars (15.9% and 29.1%, respectively).

## **RECEIVED REMITTANCES (FROM ABROAD)**

In June 2025 from abroad to Kazakhstan were transferred via IMTS 48.6 thousand transactions in the amount of 18.6 billion tenge. Compared to May 2025, the number of money transfers received decreased by 4.5%, and the volume of operations decreased by 2.4%.

In terms of the amount of money received from abroad, the leaders are: Russia - 4.5 billion tenge (a share of the total amount - 24.2%), the United States of America - 3.0 billion tenge (a share of 16.4%), Turkey - 1.9 billion tenge (a share of 10.3%), Uzbekistan - 1.88 billion tenge (a share of 10.1%), as well as Germany - 1.58 billion tenge (share - 8.5%).


